




# Environmental Policy

As a socially responsible company, we at Limesquare Vehicle Rental do are best to use new technologies and follow principles to make the most efficient use of our natural resources.

Currently, we seek to minimise our environmental effects by:

1. Purchasing engines which are “environmentally friendly”, by virtue of lower fuel consumption, safer emissions, reduced noise and greater longevity. The majority of our fleet have *Euro 5* engines, and many of our vehicles employ *stop-start* technology.
2. Monitoring fuel usage for each vehicle and taking action to ensure optimum consumption figures are obtained.
3. Implementing planned maintenance programmes which maximise the efficient use of engines, brakes, tyres etc., with consequential environmental benefits.
4. Monitoring vehicle emissions on a regular basis and taking remedial action as required.
5. Limiting the volume of materials used in our business and reducing their impact on the environment by:
  - Minimise all waste generation in office and rental operations by:
    - Scanning and emailing documents wherever possible to avoid printing or faxing

- Reusing materials, including paper, plastics, metals and rubber wherever possible
  - Using appliances that can be refilled, including toner cartridges, soap and chemical dispensers
  - Employing *self feeders* to regulate chemical dispensing
  - Utilising an increasing number of renewable products and resources
  - Recycling materials, as opposed to using landfill
  - Using ozone-friendly products
  - In particular, the use, storage and disposal of oils, paints, solvents and chemicals will be managed responsibly, to avoid or minimise adverse environmental effects.
6. Ensuring all electrical equipment enters power save mode when not being used in the last five minutes, or switched off when not in repeat use.
7. Employing the use of video conferencing technologies so as to avoid travelling, consequently reducing our carbon footprint.

Organisations that seek to supply Limesquare Vehicle Rental Ltd with goods, works and services will be made aware of the Group's environmental policy to enable them to develop and promote their own environmental initiatives. We will seek to influence, through our purchasing power, suppliers and subcontractors to adopt responsible environmental policies, by:

1. Implementing where appropriate, a "Buy Recycled" policy as part of an overall purchasing strategy that includes the choice of environmentally sound manufacturers and that utilises to the maximum extent practicable, reusable products, products made with recycled materials, products designed to be recycled and products with minimal or returnable packaging
2. Purchasing goods and services from suppliers and subcontractors who can demonstrate, or who are committed to achieving an acceptable level of environmental management

3. Issuing contract documents for the implementation and maintenance of works and services, which incorporate requirements for the protection of the environment.

Limesquare Vehicle Rental Ltd will seek to minimise its adverse effects on the environment by:-

1. Appointing individuals to be responsible for environmental management issues
2. Setting clear environmental objectives, which are relevant to the nature, scale and environmental impacts of our activities
3. Identifying performance targets by which progress towards these objectives can be reviewed and monitored
4. Sharing information on the causes of any accidents, incidents or complaints
5. Auditing the management system and reviewing the findings

Limesquare understands that vehicle rental is not the most environmentally friendly of businesses, however we constantly strive to do the most we can to reduce our carbon footprint. We also always appreciate feedback from our customers and suppliers with suggestions as to how we can further improve our environmental policies.
